External debt covers all contracted obligations in which debtors agree to repay the principal amount to the nonresident creditors, both with or without interest payments. All types of non-equity liabilities are incorporated, regardless of currency denomination and types of debt instrument.</p> <p>External debt outstanding amount collected in the form of original currency is converted to US dollar equivalent using end-of-period New York closing rate (average rate between buying and selling rates). This is in accordance with the standard stated in External Debt Guide and the BPM of the International Monetary Fund</p> <p>Debt service payment consists of (1) principal repayment on long-term debt and (2) interest payment, both on short- and long-term debt contracts.</p> <p>External debt statistics are classified by 1) Instrument type : loans, debt securities, deposits, and other debt liabilities; 2) Sector : general government, monetary authorities, bank, and other sectors (state enterprises and private enterprises) 3) Maturity : short term and long term.</p>
